DECLARATION OF DEMANDS:

We the People demand the full and immediate restoration of our inalienable rights and freedoms.

When in the course of human events, it becomes necessary for a multitude of people around the world to come together to stand up in defense of their inalienable rights against the oppression and abuse heaped upon them by the Fascist collusion of government, corporations and non-governmental organizations working together to strip the people of their many freedoms, a decent respect for the opinions of mankind requires that we should declare the causes which impel us to seek redress of our grievances.

It is abundantly clear that governments, corporations and organizations around the world have collectively infringed upon our inalienable rights of: Life, Liberty and the Pursuit of Happiness.

When a long train of abuses and usurpations, invariably pursuing the same goal, demonstrates a design to place We the People under absolute despotism, it is our right and it is our duty to stand up for our rights.

I. CORE PRINCIPLES:

2. Governments do not have the authority to suspend human rights because of so-called "emergencies." The declaration of an "emergency" does not give anyone the right to infringe upon anyone's inalienable human rights. Regardless of the scope and/or severity of any disease outbreak or pandemic, human rights remain inalienable and may not be abridged.

3. Health care must be guided by clinical/medical practitioners (not politicians, academics or "public health" bureaucrats) and decisions must ultimately be made based on the individual's choice.

4. Discrimination based on medical status is wrong and must not be permitted in any form whatsoever.

5. Health care, including pandemic response, must be decentralized. Power and governance must flow from the bottom up, not from the top down.

II. INALIENABLE RIGHTS:

We the People pledge to each other our Lives, our Fortunes and our sacred Honor to defend the following inalienable rights:

- **10. Every government, corporation and organization** must respect and honor all of these inalienable rights despite any declaration of a state of emergency.

III. WORLDWIDE DEMANDS:

We the People demand that the following changes be enacted with immediate effect:

- 1. WE DEMAND that the use of the COVID-19 injections be immediately stopped worldwide. #StopTheShots
- 2. WE DEMAND an immediate halt to all emergency declarations, lockdowns, curfews, travel restrictions, and mandates of every kind.
- 3. - 8. WE DEMAND that all government contracts be made fully available to the public.
- **9.** WE DEMAND that the governments of the world pass legislation to eliminate the conflict of interest involving government employees, international organizations, academic institutions, the pharmaceutical industry and the media.
- **10. WE DEMAND** that every batch of every pharmaceutical product including drugs, testing equipment, personal protective equipment and injectables undergo rigorous testing and chemical analysis and be delivered with an independent analysis report of all ingredients and contaminants found in the product.
- **11. WE DEMAND** clear evidence of causality including true isolation of any pathogen and proof of pathogenicity according to Koch's postulates.
- 12. WE DEMAND that RT-PCR testing NOT be used to diagnose "cases" of infectious disease. Whenever PCR tests are used to assist clinical work, the PCR cycle threshold and the genetic sequences used in the test MUST be included with the laboratory reports and in all data collection programs.
- **13. WE DEMAND** that absolutely no restrictions be placed on access to nutritional and herbal supplements.
- **14. WE DEMAND** that natural therapies including, but not limited to acupuncture, chiropractic, homeopathy, Ayurvedic medicine, Traditional Chinese Medicine (TCM), herbalism, nutrition and many other systems of health maintenance and health care, be treated on an equal footing as pharmaceutical medicines including, but not limited to inclusion in medical school training and licensing of doctors.
- **15. WE DEMAND** that the World Health Organization (WHO) must stop its attempts to capture additional legal authority/sovereignty over the people of the world. The WHO is currently involved in discussions of a "Pandemic Treaty," as well as ongoing attempts to amend the International Health Regulations while they have absolutely failed to address the important DEMANDS made by We, the People of the World. The WHO must be exposed, stopped, defunded and abolished.

IV. DEMANDS THAT ARE SPECIFIC TO THE UNITED STATES CONGRESS:

1. WE DEMAND that the Congress of the United States follow the dictates of the law (50 U.S. Code § 1622) and immediately vote upon joint resolutions to instruct the President to end all 42 of the currently active "National Emergencies."

2. WE DEMAND that Congress enact legislation providing Congress with the same authority as found in 50 U.S. Code § 1622 to vote every 90 days to end any and all Public Health Emergencies declared by the Secretary of the Department of Health and Human Services.

3. WE DEMAND that Congress repeal the 1986 National Childhood Vaccine Act and the 2005 PREP Act in order to remove the protection from liability for damages that was unconstitutionally given to "vaccine" manufacturers and health care workers.

4. WE DEMAND that Congress repeal the CARES Act and never again include financial incentives based on diagnoses of specific diseases as was provided in this Act.

5. WE DEMAND that Congress pass legislation to eliminate the Emergency Use Authorization process which has clearly been abused and turned into a profit center for pharmaceutical and medical equipment companies.

6. WE DEMAND that Congress pass legislation to put an end to all gain-of-function research.

7. WE DEMAND that Congress pass legislation to put an end to all gene therapy (or other therapy) that may result in "shedding."

8. WE DEMAND that Congress pass legislation outlawing the advertising of pharmaceutical drugs to consumers and also restrict the financial influence that pharmaceutical companies have over medical and scientific journals.

9. WE DEMAND that Congress pass legislation to ensure complete and immediate transparency of the results in all clinical trials and all ongoing data collection.

10. WE DEMAND that Congress pass legislation to improve and expand the Vaccine Adverse Event Reporting System (VAERS) to make it far more user friendly so that it is fit for the purpose for which it was originally created.

11. WE DEMAND that Congress pass legislation to provide financing for autopsies and pathology reports to assist in accurate determinations of the true cause of death.

12. WE DEMAND that Congress pass legislation to properly fund the Countermeasures Injury Compensation Program (CICP) and restructure the guidelines to better compensate those who have suffered injuries from the COVID-19 injections and/or other authorized treatments.

13. WE DEMAND that Congress pass legislation that clearly and legally defines the following terms: "case," "effective," "emergency," "pandemic," "safe," "vaccine."

14. 18. WE DEMAND that Congress enact legislation designed to overhaul the manner in which the HHS, NIH, FDA, CDC, and NIAID allocate research funding by creating an impartial research funding agency.

19. WE DEMAND that Congress repeal the Bayh-Dole Act of 1980 (35 U.S.C. 200) in order to eliminate the conflict of interest of government employees and federal contractors earning income from patents obtained as a result of government-funded research.

20. WE DEMAND that Congress investigate countless allegations of fraud, corruption, conflict of interest, violations of rules regarding informed consent, accusations of contaminants and deficient levels of mRNA in the vials of COVID-19 injections, and many other criminal acts.

21. WE DEMAND that Congress thoroughly investigate the role that the Department of Defense (and other government agencies) have played in the development of biological weapons.
